### **MARKET GUIDELINES**

**HOURS:** The Market runs weekly on Thursdays from 6pm – 9pm until September

Vendors must be set up and ready to sell at 6pm.

**BOOTHS:** Vendor booths will be 10 linear feet of display space as assigned, depth varies

**FEES:** Fees can be paid by Cash, Credit or Cheque – Cheques to: The Peppercorn Restaurant

**WASHROOMS:** Available inside The Peppercorn Restaurant, handwashing also available outside

**VENDING/PRODUCTS:** The Peppercorn Restaurant makes no non-competition guarantee to any vendor. Vendors labelling products as “organic” must provide appropriate certification.

Vendors must show the origin of any produce they are selling. Vendors must have all applicable permits. Vendors must provide their own tables/chairs/displays and remove at the end of the market

**PARKING:** Vendors must park their vehicle wholly within their site or in designated parking lot.

For safety reasons, vendors may not move their vehicles during the market hours

**LOSS:** The Peppercorn Restaurant is not responsible for loss or damage to vendors' products or personal property and does not provide warranties or guarantees of vendor products

**CONTROL, HEALTH & SAFETY:** The Market Coordinator has final authority on all aspects of the market. Vendors are responsible for their own liability insurance. Vendors with tents or awnings must ensure canopies are secured in case of wind gusts. Vendors selling food of any kind must comply with any and all regulations and requirements as set by MB Health

**GARBAGE:** Vendor areas must be left clean. Food vendors providing samples are required to provide containers for any garbage produced by their stall. Garbage can be transferred to The Peppercorn garbage bin at the end of the market.
